

# CERTIFICATE III IN BEAUTY SERVICES SHB30115

At the Australasian Beauty Therapy Academy (ABTA), we aim to provide students with a reliable, and flexible learning and assessment process, where evidence gathered through a range of methods is validated against the unit of competency.

All practical sessions take place in school hours and in the Student Clinic. The Student Clinic simulates a Beauty Salon environment and provides actual beauty services to members of the public. In this environment, students are able to apply the full range of competencies against learning outcomes in a supervised environment.

This continuous assessment process, which is on going for the full duration of the course, provides strong evidence to support the student's final course outcome as well as a tool for constant student feedback and improvement during the course.

## 1. DESCRIPTION:

This qualification reflects the role of individuals who are competent in interacting with customers, providing a range of beauty services which include make-up, waxing, nail service, lash & brow treatments, and demonstrating and selling retail skin care and other cosmetic products.

#### 3. ASSESSMENT INCLUDES:

- Attendance record (class attendance)
- Practical exams for: Lash & brow treatments; Basic Waxing; Makeup I; Manicure/Pedicure; Spray tan; Lash extension; Ear Piercing; Gel nail and Nail art.
- Clinical practice
- Assignment for each unit (short-answer questions)



## 4. STUDY METHOD:

#### Distance learning plus practical in-house training and assessment:

You are required to attend all training classes for the practical units, and complete assignment for each unit at comfort of your own home, submit them in once they are completed. You will have assistance and support at all time, even on the weekends, you can contact the tutor by phone or email if you need help with your study. The assignments need to be submitted via email.

You are required to attend the practical training classes for the following units/short courses:

Lash & brow treatments; Basic Waxing; Makeup I; Manicure/Pedicure; Spray tan; Lash extension; Ear Piercing; Gel nail and Nail art.

## 5. COURSE DURATION AND COMPLETION DATE:

To graduate and receive your award certificate, you are required to complete all the course requirements within six (6) months after commencement date of the course in accordance with the ABTA Student Policies and Procedures.
